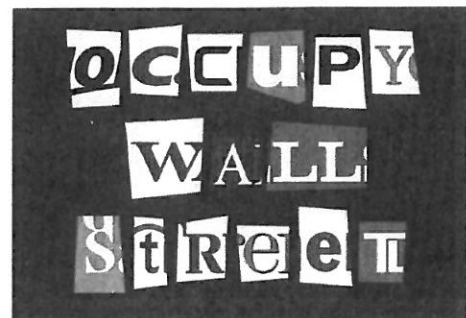
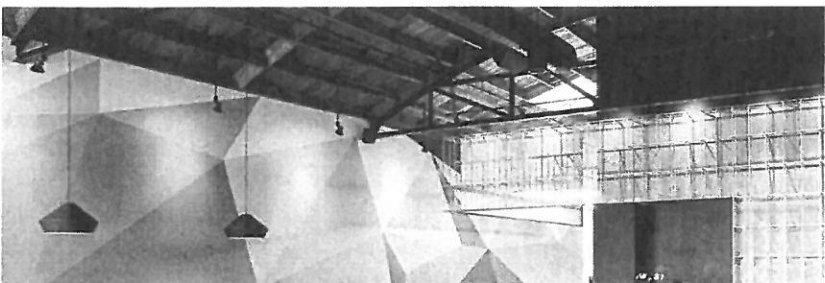


## // BIO

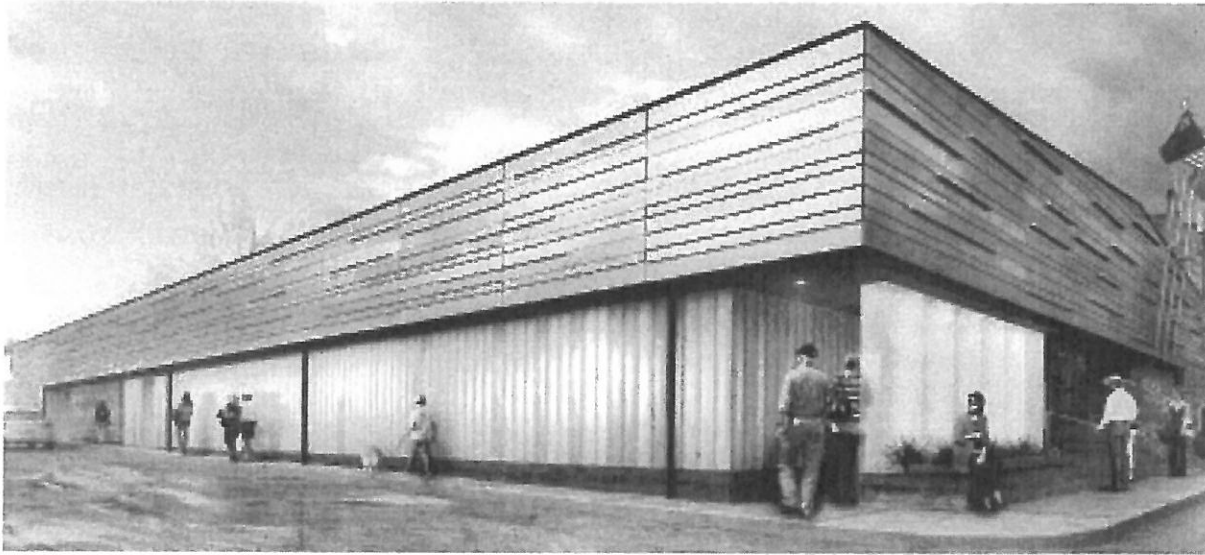

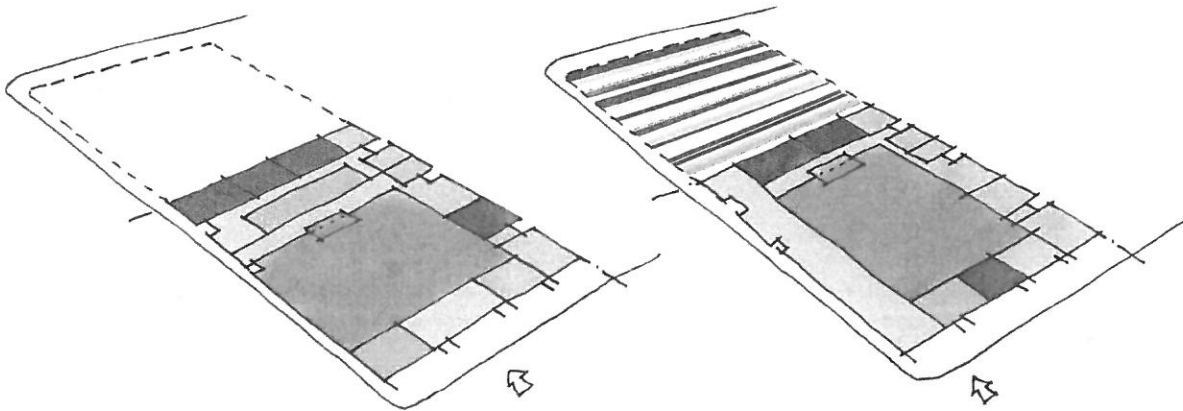
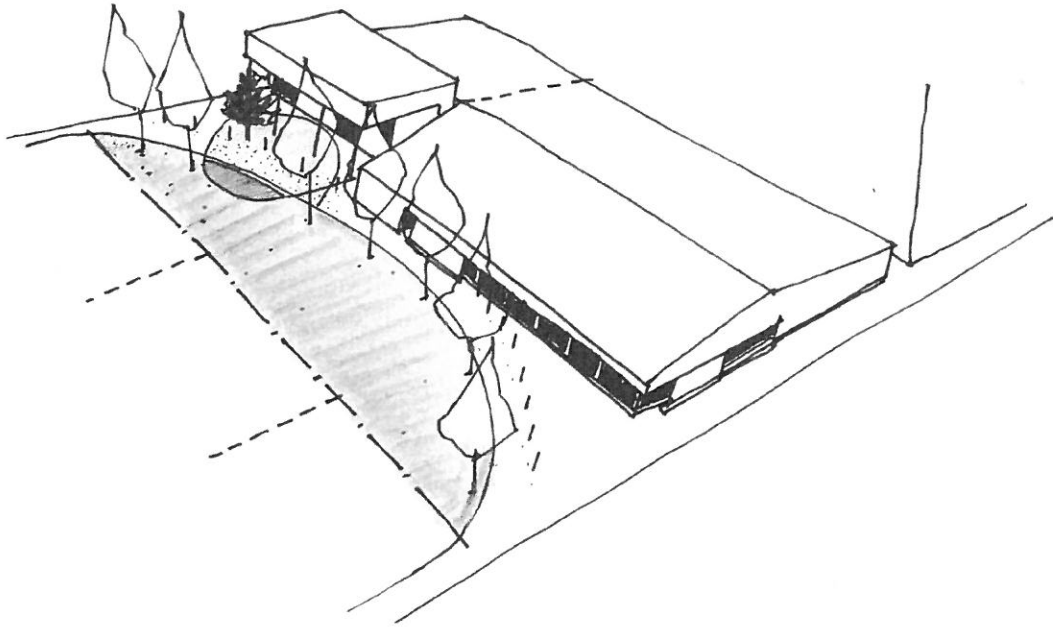
// ACCESSMENT OF CURRENT BUILDING'S LAYOUT
