#### 3. **PUBLIC COMMENT**

George Chachas commented on agenda item 4.C.5. He felt that needed to be denied. The grants being requested are asking for full funding and not just advertising and promotion as was allowed in years past. Some are not tourism related and that shouldn't even be considered. He has yet to see anything on the agenda regarding Broadbent Park and the retaining of the present grandstand. He has not seen anything regarding the Heritage Park.

# 3. Preliminary Budget Review for Fiscal Year 23/24 Budget

Director Horvath said the highlighted areas are where there have been changes in the budget. The non-highlighted areas are basically a pass-through recommendation from our current approved budget.

Line-item Room Tax City and County. Mr. Horvath is recommending a proposed increase of six percent. Line-item Historic Asset Maintenance. This was initially geared towards preserving historic assets. Mr. Horvath suggests changing this line item to Façade Improvement Incentive Program or FIIP and increase it by \$20,000. This change will benefit the whole redevelopment district better.

Line-item Consulting Services. It is recommended as a reduction from \$125,000 to \$100,000 to reflect eliminating consultants.

Line-item White Public Museum. It is recommended that an increase from \$22,000 to \$25,000 to help support the Ping Pong train that will be coming through.

Line-Item Outdoor Recreation Grants. This is an earmark through the City where .5 percent of the 13.5 percent needs to go to outdoor recreation grants. With the increase of six percent, then this needs to be increased as well. This comes out to \$65,000.

Line-item Capital Outlay. Quite a bit was budgeted this year because of convention center upgrades and renovations. Mr. Horvath has reduced this from \$155,000 to \$50,000.

Due to Other Governments. A six percent increase is reflected here also. These parity the increase in the revenues.

Finally, this proposed budget shows a \$12,480 surplus.

Chairman McIntosh wanted to discuss insurance saying that our insurance agent said it will be going up this year. Mr. Horvath said it goes up every year but neither of them knew what the increase was going to be so this item will expect to be augmented.

Member Van Camp asked if there was ever overtime for the employees. Mr. Horvath said the non-full time, non-salaried employees are eligible for overtime. He said usually only the employee in the Maintenance Department gets overtime and that is usually during the holiday season. Mr. Horvath said they budget rather correctly for any overtime.

Chairman McIntosh said she felt we had the flexibility on one employee that could have more responsibility with additional compensation. It may not be adding a person but changing the job description.

Mr. Horvath felt from looking at the goals of the Board that this preliminary budget reflects what the Board has indicated.

Member Van Camp disclosed that she is a member of the White Pine Public Museum and because of that she didn't feel like she should vote on this agenda item. Legal counsel Hilton felt that since it does not benefit Member Van Camp personally in any way and that she won't be receiving money, that she is able to vote on this item. Legal counsel Hilton said that Member Van Camp properly disclosed but the law

favors full disclosure and voting unless there is a reason to abstain so she felt Member Van Camp was fine to vote.

Chairman McIntosh said we will have the final budget hearing in May

Motion: Member Carson moved to approve the preliminary budget as presented for Fiscal Year 23/24.

# 4. Approval to modify and/or renew McKinzie Hilton's legal services contract to \$750/month for five hours per month, effective July 1, 2023

Chairman McIntosh turned the meeting over to Vice Chair Henry since McKinzie Hilton is her daughter-in-law and she will be abstaining.

Vice Chair Henry asked if everyone has had an opportunity to review the contract. They answered in the affirmative.

# Approval for letter of support for SB186

Chairman McIntosh said SB186 is a 99-year lease for the East Ely depot museums to stay exactly where they are. It allows for actual fixing of the buildings. They have been thirty years without the repair that has been needed. The biggest critical issue for our history and culture is that the records have not been kept. This is a joint property of the City and the railroad foundation. The records would be digitized and preserved. This would relieve the State of a lot of liability and expense.

Member Van Camp said she felt is the job of Tourism and Recreation is to promote both entities and she thinks it is doing a disservice to pick one over the other. She is not in favor of sending a letter for or against this bill.

Member Carson said the City of Ely supported this and he appreciates what the railroad is trying to do but he agrees that Tourism and Recreation should remain neutral on this since we work with both parties.

Member Wright also felt that Tourism and Recreation should remain neutral.

Vice Chair Henry said her main concern is securing the records. Mr. Horvath said it seems the main concern of the Board is the security of the records. He asked if it was something whereby Tourism and Recreation could partner to support preserving the records and just deal with that issue specifically. Perhaps there is money or grants where we could just address the problem.

Legal counsel Hilton put on the record that she advised Chairman McIntosh that she does not need to abstain from voting on this item as a member of the Railroad board because she does not benefit

personally in any way from the letter of support for SB186. Chairman McIntosh disclosed and took part in discussion based on this advice.

Chairman McIntosh said our question is the letter of support for SB186 and what we have been delving into is the records part of this. She suggested that perhaps we could table this and come up with some solutions that could be of help.

# 6. Discussion and/or approval of White Pine County and Recreation Board Personnel Policies

Chairman McIntosh complimented Nicole for taking over the HR role. This is a complete personnel update. They are not yet complete. The main thing is that our employees have read and understand them. We will bring this back as far as approval. Nicole has kept Director Horvath up to date on any changes. These will be updated again in about a year because of the legislative session. This will be ongoing.

## 7. Update on Great American Eclipse

Director Horvath said an eclipse is coming across America on October 14, 2023. The path of totality is coming right over White Pine County. We are marketing this to be the destination to come view. Our first meeting included land managers, the sheriff, fire, emergency personnel to figure out how to handle the influx of people. We want to showcase everything that we have to offer and not just on the day of the eclipse but the days leading up to and after. Out of the meeting came areas where the county and city are okay sending people. Those places are the White Pine fairgrounds, the Nevada Northern Railway complex, Baker, Great Basin National Park, rest stop at Schellbourne Pass, possibly the golf course and downtown Ely. We are working on a seven-day calendar of different events. Nevada Northern Railway have secured NASA and the San Francisco Exploratorium to come out and live stream the eclipse internationally. White Pine Main Street received a grant to do a logo and a poster. Those are open source for everybody. This gives the community the opportunity to showcase what they do.

# 8. Update on National Park Service Rivers and Trails Project

Director Horvath said two weeks ago a representative from the National Park Service River, Trails and Conservation grants program was here for an on-site visit. We received the grant for a complete and total asset mapping of all our recreation opportunities and how they play and interconnect with each other. Planning for growth and making sure we are utilizing recreation corridors, trails and alternative transportation like the railway to get people off the highways and still be able to access all of the recreation. There were eight items identified by the land managers as potential SNPLMA projects that would connect our communities.

# 9. Update on Destination Development Demonstration Grant

Director Horvath said the river, trails and conservation grant is one small but important piece to the larger destination development grant. Last week the consultants for that were in town and we did a full site visit of everywhere in the County. We brought everyone up to speed on our vision and how we are moving forward. What does White Pine County look like in 2033? What is our goal for what the impact of tourism is? We are geared toward looking at growth and how we can sustain it. The next step is to compile all the responses from the community.

# 10. Aid to Organization Grants

Director Horvath said the purpose of tourism is to use the money that visitors leave in our community and reinvest it into our community and quality of life assets. Normally in the past we have had a budget of about anywhere from \$70,000 to \$80,000 in our budget for the aid to organization grants. This is more specifically for putting on events with events being the driving catalyst in this community. This year we received almost \$200,000 in requests for what was recommended in the preliminary budget of \$80,000. Legal counsel Hilton went through all the requests and checked their status and eligibility. We did find some organizations that were not eligible. Those will get pulled. We do have a line item that is tour and recreation events which is there to support events that were not eligible or did not receive any money. Legal counsel Hilton said she will jump in anytime someone needs to make a disclosure to just remind you of that disclosure. She said no one will need to abstain since no monies are received and no one personally benefits.
