3. **PUBLIC COMMENT**

George Chachas spoke to agenda items C5 and C6 regarding the rebranding of the convention center. He reminded the Board that the convention center was built from the donations of the business community to boost business in the downtown area. He said the Board is failing in its mission. How many conventions have been brought in since Kyle Horvath has been here. You need to refocus. He said the Liberty Bar mural and the Hotel Nevada mural need refreshing before you consider new murals. On agenda items C8b and C9i regarding the Nevada Northern Railway requests, they should be denied until the railroad starts operating under the Nevada Open Meeting Law. On agenda items C9h and C9k to the Renaissance Society, some of that grant money should be prioritized to painting the buildings before they completely dry up and splinter. He has yet to receive any information regarding why the contract with young Tom Bath was cancelled. He has yet to receive any information regarding the Silver State property as to whether it has a proper business license. He has not received any updated information on the itemized inventory list of the convention center. The money that was given to the community choir for pigeon control must come

Approval of Insurance Renewal of Nevada Public Agency Insurance Pool (POOL) for 4. Fiscal Year 2024/2025 from Warren Reed Insurance Company by Alan Reed

Alan Reed was present. He briefly went through the renewal summary. The cover letter shows who the carriers are. There are 141 members in the Nevada Public Agency Insurance Pool. We fall under the category of Special Districts. He said the Pool has had a long-lasting relationship with Lloyds of London. We are now in the twentieth year. The world of insurance is struggling with wild land fire losses and with law enforcement liability. Referring to some of the coverages mentioned within the summary, Mr. Reed highlighted cyber liability. He said this is a particularly challenging area for governmental entities. There is a cap on the cyber insurance of one million dollars. It used to be three million dollars up until a couple of years ago. He felt it was important to mention in reference to the grant program, that if you have something that deals with risk mitigation and loss prevention, that the Board may want to consider an application for the grants available. He spoke to the member services that exist within the Pool structure. He said the number one item that was used most in the past year is the learning system, the webinars. Of the couple of items that Mr. Reed mentioned, one of them that is affecting costs is property values. When values go up, rates go up. Mr. Reed pointed out what the Pool is really like behind the scenes. He said the Pool underwrites a lot of exposures such as property insurance, amount of payroll, number of autos which are the drivers for the rates. He referred to a page in section two, page 8, that tells the Board exactly where their dollars go and why your rates and program costs change from year to year. There was a slight increase of a little less than ten percent. Our exposures are being driven by payroll and property values with payroll being the biggest factor. He gave a breakdown of the figures shown in the graph for the budget of the Nevada Public Agency Insurance Program. In summary, the convention center is currently insured for 3.3 million dollars and the rental building is at 1.131 million dollars.

Chairman McIntosh thanked Mr. Reed for the thorough presentation.

Mr. Horvath said shown in the proposal for professional services on Page 3 of the email, Phase 1 Scope is reiterated again. It breaks out the fees, so you know where the money is going. Forty-Eight thousand, six hundred includes the mechanical, plumbing, electrical, engineering, architecture and project management. Mr. Horvath said an amount of \$65,000 was budgeted.

He went through each item highlighted in Income and Expense. After the augmentations are done, we are showing that we will finish with an operational surplus with that profit going into the savings account which will be used later for the phases of the convention center work.

She said at the last budget meeting the Capital grant amount was raised to \$85,000 and the Outdoor Rec grant amount was raised to \$70,000.

6. DISCUSSION/INFORMATION ITEMS

A. Executive Director's Report

Director Horvath referred to his report for the period of May 28 to June 25. He went over the various meetings he attended. He was voted in as the new President for Pony Express Territory and as the new President for the Nevada Outdoor Business Coalition. Room tax revenue was up 4.6% over May 2023. We are on par to exceed room tax revenue projections for fiscal year 2023/2024. He applied for \$39,000 in grants; he received the award letter showing \$32,000 was awarded. The summer concert series starts in July. The excursion trails are running; the WP Public Museum is open seven days a week; and the McGill Drugstore is open Friday-Sunday. He gave an update on the upcoming meetings and events. He gave a brief update on the on-going projects and the goals.

B. Marketing Director's Report

Marketing Director Porter gave his report. Facebook was up eighty-six followers. Four posts were boosted. Instagram followers and reach were both up. Threads was up and X stayed the same. For our targeted digital through Reach Local, our numbers are consistent when it comes to our impressions and ads. He gave the top pages visited through the website and the top ten referrals on how people learn about Ely. Mailchimp was up again. He gave the top links that were clicked.

7. PUBLIC COMMENT

George Chachas said he has not been provided with the last inventory list. He said the Convention Center parking lot and center dividers are not ADA compliant. He said to date you have not provided any rental agreement with Ian Bullis or the Food Bank. He sees contractors are remodeling. When did you approve remodeling; where is the plan; how much is the Food Bank paying for the changes taking place. He is requesting a copy of any plans this Board has approved and the agenda dates this Board approved them in an open meeting. At the meeting held on May 28, 2024, he requested a copy of the events calendar for March and April and now for May. He would like to know if you refuse, and he is requesting your basis for refusal in writing. In your reports today, he said you had JT Steak House advertisement, which is okay, but we also have restaurants in the downtown area, and they are not getting any recognition. He still has a concern on the parking lot and the center walkway. Not ADA compliant. He is still concerned as to why you are paying \$64 for Doris Lawler. He has also asked for information regarding Ed Spear who was a

contractor of the Tour and Rec Board. Does he have a state business license, city license, commercial location, home occupation, etc. He said the open meeting law says five days, not five years.

8. ADJOURNMENT - Chairman McIntosh adjourned the meeting at 5:33 pm.
